



**Yolo Local Agency Formation Commission  
Notice of Availability of Draft MSR/SOI and Public Hearing**

NOTICE IS HEREBY GIVEN that on **Thursday, February 22, 2018, at 9:00 am**, or as soon thereafter as the matter may be heard, the Yolo Local Agency Formation Commission (LAFCo) will hold a Public Hearing at the Yolo County Board of Supervisors Chambers, 625 Court Street, Room 206, Woodland, CA to consider adoption of a:

**COMBINED MUNICIPAL SERVICE REVIEW (MSR) AND SPHERE OF INFLUENCE STUDY (SOI) OF THE 16 RECLAMATION DISTRICTS / LOCAL MAINTAINING AGENCIES IN YOLO COUNTY**

The intent of the Municipal Service Review (MSR) is to review the services being provided by all sixteen reclamation districts (RDs) and/or local maintaining agencies (LMAs) in Yolo County. Those agencies include Reclamation Districts 150, 307, 537, 730, 765, 785, 787, 827, 900, 999, 1600, 2035, 2076 and 2120, County Service Area #6 (Snowball), and the Knights Landing Ridge Drainage District. The MSR also makes governance recommendations for each hydrologic basin along the Sacramento River flood system. On the basis of the MSR and in accordance with Government Code Section 56425(g), staff has reviewed the Spheres of Influence (SOI) of each agency and recommends that a SOI Update is necessary for RD 537. The SOI proposes to add the Department of Water Resources Maintenance Area 4 (MA #4) to the RD 537 SOI.

The Draft Combined MSR/SOI for the Reclamation Districts/Local Maintaining Agencies in Yolo County **will be available for public review beginning January 31, 2018 and ending February 22, 2018 at 9:00 a.m.**, at the office of the Yolo LAFCo and online at [www.yololafco.org](http://www.yololafco.org). To be included in the staff report, written comments on the MSR Study and/or the SOI Update should be returned to the LAFCo office by **February 12, 2018**, either by mail at the address stated below or via e-mail to Yolo LAFCo Executive Officer Christine Crawford at [lafco@yolocounty.org](mailto:lafco@yolocounty.org). Comments received after that date will also be considered, but included in a supplemental packet to the Commission.
