# In-Home Supportive Services Advisory Board

---

**Purpose:** This board submits recommendations to the Board of Supervisors on the preferred mode or modes of service to be utilized in Yolo County for In-Home Supportive Services. They shall also provide ongoing advice and recommendations regarding In-Home Supportive Services to the Board of Supervisors, any administrative body in the county that is related to the delivery and administrative agency of any public authority, nonprofit consortium, contractor, and public employees.

**Makeup of membership:** 11 rotating members who shall be appointed by the Board of Supervisors as follows:

Category A: six consumer members who shall be residents of Yolo County who are current or past users of personal assistance services paid for through public or private funds or as recipients of In-Home Supportive Services

Category B: five categorical members who shall reside or work in Yolo County who are appointed from each supervisorial district as follows:

- At least two members of the Committee shall be current or former providers of In-Home Supportive Services
- Individuals who represent organizations that advocate for people with disabilities or seniors
- Individuals from community-based organizations that advocate on behalf of homecare employees may be appointed to the committee
- One Yolo County employee

**Membership terms:** 4 year terms; commencing Feb 1

**Frequency and time of meetings:** Meets the first Wednesday of each month from 1:30-3:30pm in the Clarksburg Room at the DESS Building, 25 N. Cottonwood Street in Woodland
