Purpose: This council identifies local child care and development priorities, develops policies to meet identified needs, and recommends, subject to the approval by the Board of Supervisors and the County Superintendent of Schools, local priorities for the allocation of child care funds administered by California Department of education: and the State Department of Education allocates child care and development funds on a county-by-county basis based upon the amount of state and federal funding available; it is the intent of the Board of Supervisors to ensure that all the child care and development needs of Yolo County are met to the greatest extent possible.

Four members who are appointed at the discretion of the appointing agencies.
