# Yolo County Advisory Committee on Tribal Matters

---

**Purpose:** This Committee, upon request from the Board of Supervisors, reviews and makes recommendations on specific issues involving the relationship of the County with the Rumsey Band of Wintun Indians ("Tribe"); makes recommendations to the County Administrative Officer on expenditures from revenues received by the County from the Tribe; receives reports, information, analysis and testimony from County and Tribal officials, local residents, and other interested parties on matters of Tribe-County relations; makes a report annually to the Board of Supervisors on the state of County-Tribe relations, and makes any necessary recommendations thereto for the improvement of that relationship, and; any other duties delegated to this Committee by the Board of Supervisors directly related to Tribal matters.

**Makeup of membership:** Nine members.

Five members: Each member of the Board of Supervisors shall recommend for appointment one person to be a member of the Committee. Those persons recommended by Supervisors need not reside in the supervisorial district of the recommending Supervisor.

Two members: Shall reside in the Esparto or Madison Area, specifically, the area identified within the Esparto Unified School District boundaries. (Board appointed)

Two members: Shall reside within the area encompassed by the Capay Valley General Plan. (Board appointed)

**Frequency and time of meetings:** Meets the fourth Monday of each month from 6 - 8:00 p.m. alternating between the Administration Building in Woodland and Esparto.
