

Main News

Mosquito and bird testing samples in Sacramento County have been confirmed as positive for West Nile Virus. The Yolo County Department of Public Health is currently analyzing and investigating the possible cases in our County.

Citizens can take preventative measures to avoid becoming infected with West Nile Virus. The Center for Disease Control recommends using an insect repellent that contains the active ingredients DEET, Picaridin, IR3535 or the plant based Oil of Lemon Eucalyptus.

HELPFUL HINTS

DRAIN standing water that may produce mosquitoes.

DAWN and **DUSK** are times to avoid being outdoors.

DRESS appropriately by wearing long sleeves and pants when outside.

DEFEND yourself by using an effective insect repellent. Make sure to follow label directions!

DOOR and window screens should be in good working condition without holes.

Building a Safer Community for At-Risk Seniors: A Yolo County Crisis to Action Summit

The number of Yolo County residents age 65 and older has increased by 25% since 2000 and continues to rise. By 2035, the population of seniors will exceed the number of children in our county for the first time. Sadly, federal, state, and local funding for vital services for senior citizens is on a drastic decline.

The Yolo County Commission on Aging and Adult Services, chaired by Yolo County Supervisor Jim Provenza, and the In-Home Supportive Services Advisory Committee hosted “Building a Safer Community for At-Risk Seniors: A Yolo County Crisis to Action Summit” on June 18 in Davis.

“With the rising demand for services by a growing number of seniors in Yolo County, we are going to need to plan an effective response to care for some of our most vulnerable citizens,” said Yolo County Supervisor Jim Provenza. “This is our chance to work together to find some real solutions.”

Summit participants began the important process of developing a community action plan to identify gaps in services, plan for future needs, and develop partnerships between government, non-profit organizations, local businesses, and community members to more effectively address these needs.
