DEPUTY CLERK OF THE BOARDORDINANCE NO. 919.8AN ORDINANCE AMENDING THE YOLO COUNTY BOARD OF SUPERVISORS'
COMPENSATION ORDINANCE

The Board of Supervisors of the County of Yolo, State of California ordains as follows:

SECTION 1. PURPOSE. The purpose of this Ordinance is to amend provisions of Yolo County Ordinance No. 919 (uncodified) to update the compensation of members of the Yolo County Board of Supervisors.

SECTION 2. AMENDMENT. Section 2 of Ordinance No. 919 is amended to read as follows.

- (a) Beginning April 2, 2017, the annual salary of each member of the Board of Supervisors shall be set at an amount equal to thirty-five percent (35%) of the annual salary paid to a judge of the Yolo County Superior Court as of that same date.
- (b) On June 1, 2018 and each subsequent June 1 after implementation of the salary adjustment described in subsection (a), above, the County Administrative Officer shall determine, or cause to be determined, the amount of each Supervisor's salary increase or decrease, if any, which is to become applicable on the following July 1. Within fifteen calendar days following the determination of each Supervisor's salary, the County Administrative Officer shall file, or cause to be filed, with the Clerk of the Board of Supervisors a written certificate which identifies and includes the following:
 - i. The current annual salary of each member of the Yolo County Board of Supervisors.
 - ii. The amount of increase or decrease, if any, the State of California has made to the salaries of judges of the Yolo Superior Court since the salary of each supervisor was last established; and
 - iii. The annual salary of each member of the Board of Supervisors following the adjustment necessary to ensure that salary of each member of the Board of Supervisors continues to be equal to thirty-five percent (35%) of the salary of a judge of the Yolo Superior Court.

Except as amended pursuant to this Ordinance, Ordinance No. 919 shall remain in full force and effect.

SECTION 3. EFFECTIVE DATE; PUBLICATION. Pursuant to Government Code Section 25123.5, this Ordinance shall take effect and be in full force on and after 60 days after its passage. Unless a summary of this Ordinance was duly published in accordance with California law prior to its adoption, before the expiration of 15 days after passage of this Ordinance, it shall be published once with the names of the members of the Board of Supervisors voting for and against the Ordinance. This publication is to be made in a newspaper of general circulation published in the County of Yolo.

This Ordinance was introduced at a regular meeting of the Board of Supervisors held on the 10th day of January, 2017 and passed and adopted by the Board of Supervisors of the County of Yolo, State of California on the 24th day of January, 2017 by the following vote:

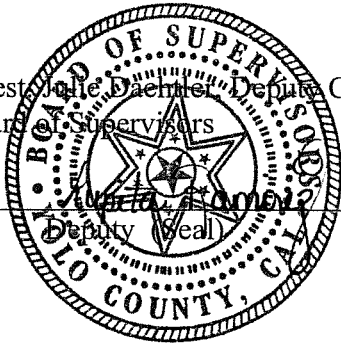
